as some of the requirements have changed for this semester*

**Section 1:** Please indicate your first, second, third and fourth choice next to the courses that you are interested in taking in the Fall. Please take note of the type of courses: Blended - This course is a seated course with all course work being submitted online. Web Enhanced - This course is also seated with a portion of the course work being submitted online. Internet - This course is entirely online, all course work and interaction with the instructor is done via the internet. In addition please note the length of the classes, either 16 or 12 weeks.

**Section 2:** Please give us your **legal name**. Feel free to add your maiden name if your name has recently changed. Also please give us your **mailing** address and specify whether you have a post office box or a cluster box. Please provide the best email address for you to be reach and also your date of birth (DOB).

**Section 3:** Please carefully read and answer all of the questions in this section. Remember that you must be employed in a licensed child care facility in Union County and you must work with children under five years old in order to be eligible to take classes through Education Stars. In addition, this year you are required to apply for financial aid. Registration for Education Stars will be blocked if you do not apply for financial aid (FAFSA). If you hold a Bachelor's Degree or higher, you will not be eligible for financial aid. Please circle "Ineligible" on the application. Keep in mind that you must apply to SPCC before you can apply for financial aid. Also, if you have been a student in the past but have not taken classes in the last 2 years, you will need to re-apply to the college. All new students, as well as students who are re-applying to SPCC will need to have their high school and college transcripts sent to: Admissions Office, SPCC, PO Box 126, Polkton, NC 28135. Your transcripts must be received before you can be registered for classes. Since this can be a lengthy process, we recommend you send for your transcripts ASAP.

**Section 4:** Carefully read and write your initials in the blank to the right of each statement. When you have read and initialed each statement, sign on the applicant's signature line and date the form. Once you have completed your portion of the application, please have your director sign at the very bottom as a confirmation of your employment status.
